

**GACS "School of Music"**  
**Private Music Lesson Business Contract**  
2007/2008 Academic Year

Please initial the payment terms that you are agreeing to for the school year: By initialing the commitment level and signing the registration form, you are agreeing to the terms of this business contract.

*There will be a \$50 non refundable registration/music book fee for each student.*  
*All piano students will be charged a \$30 instrument maintenance fee once a year.*

1. \_\_\_\_\_ **Full Year Commitment:** I am committing my child to a full year of private music lesson instruction. I understand that the charge for the year will be \$945 and will contain 32 half hour lessons. (\$1420 for a 45minute lessons/ \$1890 for a one hour lesson) I understand this fee will be billed by the business office and paid on the same pay schedule as my tuition plan.

2. \_\_\_\_\_ **Full Semester Commitment:** I am committing to a full semester of private music lessons instruction. I understand that the charge for the semester will be \$525 and will contain 16 half hour lessons (\$790 for 45 minutes/ \$1050 for one hour). I understand this fee will be billed by the business office and paid on the same schedule as my tuition plan.

Because our teachers are active professionals in the music community, they have a limited number of openings in their schedules. The GACS School of Music cannot guarantee that all students who register will be able to participate in the lesson program. Students are accepted on a first come first served basis with previous students getting the option of pre-registration. Every measure will be taken to try and place each student. If lessons cannot be arranged by September 1, 2007, all monies will be refunded.

Students are allowed to make up **two lessons** within the GACS school calendar for excused lessons only. An excused absence is one in which the music office or private lesson teacher receives 24 hours prior notice. Only lessons missed due to school closing or teacher absence will be re-scheduled.\*\*\*

\*\*\*\*In the event that a student/parent wishes to terminate instruction, a 30 day written notice to the School of Music office is required. If withdrawing before a yearly or semester contract is complete, the amount refunded will be at a rate of \$25 for each lesson remaining in the contract period.\*\*\*\*
